## **RESEARCH INTEREST**

My research concerns the determinants of strategic decisions by firms and how the series of decentralised decisions translate into an aggregate dynamic. By strategic decisions, I mean decisions which may jeopardise firm survival or, conversely, enhance their growth, such as product diversification, R&D investments, price-costs margins, product or process innovation, and export participation. In my research, firms are heterogeneous in their efficiency and their determinants thereof. Hence, macro-economic growth and industry evolution conceals a complex web of microeconomic decisions by heterogeneous firms.
